Dep Rose Comments
Mr. Anderson said that he has had several problems with his sister in the past. These problems are a result of their mother and her health problems. Anderson said they have gone to court on several different occasions and his sister, Diane Anderson, has caused many problems with their mother (mother has alzheimers disease). Anderson said his sister is not allowed in his house. While he was at work his wife and mother came to Mt. Pleasant and saw him at work. When they returned home they found a bag of cookies and a note saying "For you mom, Love Diane". Anderson stated this causes problems with his mothers health, as she will get excited. He said he did not wish to press charges against Diane. He just wanted it on record. He said there was an open door at the house, however she is not allowed to come and go from his house ever, especially when nobody is home. Nothing further at this time, as caller did not want it sent to the prosecutor for review. tr
